Mayor Woodards informed Council Members of a press release from TPD Interim Chief Mike Ake regarding action that was taken at the Pierce County Council meeting today, where Council Chair Derek Young directed Pierce County Council staff to begin the process of finding an independent investigator to examine the events of January 27, 2021, regarding Pierce County Sheriff Ed Troyer. She stated that she plans to release a statement in support of TPD Interim Chief Ake and invited Council Members to voice their interest in releasing a joint statement from the City Council, supporting an independent investigation.
