

**AMENDMENT NO. 2 TO CONTRACT #4600010725
COMPREHENSIVE LIFE RESOURCES – POSITIVE INTERACTIONS**

THIS AMENDMENT is made and entered into effective as of the 5th day of October, 2016, by and between the **CITY OF TACOMA**, Department of Neighborhood and Community Services (hereinafter called the "CITY") and **Comprehensive Life Resources** (hereinafter called the "CONTRACTOR").

WHEREAS the CITY and the CONTRACTOR entered into a Contract for 24/7 response services to businesses in the community impacted by individuals struggling with mental health and/or substance use disorders and concurrent homelessness, under the program Positive Interactions (herein "Contract") on or about January 1, 2015, and

WHEREAS the CITY and the CONTRACTOR entered into Amendment No. 2 to the Contract on or about September 23, 2016, for the purpose(s) of expanding the program, and

WHEREAS the CITY and the CONTRACTOR desire to amend the Contract in order to increase staffing by 1 FTE (Mental Health Professional) to provide crisis response and mental health screening, improved data collection through the purchase and use of ArcGIS data collection program, provide onsite case management and treatment planning for housing first clients (Hotel Vouchers), provide 40 Housing First units at a city designated location, increase response (ensuring a 24/7 response to businesses) and increasing community and encampment cleanup, and

NOW, THEREFORE, in consideration of the mutual promises and obligations hereinafter set forth, the parties agree as follows:

1. The sum authorized for services under the Agreement is hereby increased by \$254,400.00 from \$401,720.00 to \$656,120.00.

The Scope of Work is also amended to include the following budget revisions:

- \$15,000.00 for .17 Mental Health Professional
 - \$22,500.00 for 1 FTE Case Manager
 - \$12,000.00 for ArcGIS data collection program
 - \$24,500.00 for expansion of community clean-ups (including encampments)
 - \$400.00 Naloxone Kits (x4)
 - \$180,000.00 to provide 40 Housing First Units
2. The Scope of Work, authorized under Exhibit "A" of the Contract, is hereby amended to include the expansion of services as identified to and attached as Exhibit "A-3" to this Amendment and incorporated herein.
 3. All other terms of the Contract, together with all exhibits, are hereby ratified and shall remain in full force and effect, unaltered by this Amendment. Should this Amendment be signed after the date Contract performance has begun, all terms and conditions herein shall operate retroactively to the date performance began
