Joint City Council/Utility Board Briefing Items

1. 15-0909 Click! Network Update

At approximately 12:05 p.m., Bill Gaines, Director of Utilities, provided a brief background of the discussions held thus far and introduced Chris Robinson, Power Superintendent. Mr. Robinson introduced Doug Dawson, CCG Consulting. Mr. Dawson provided an update on future options for Click! Network, and discussed policy objectives, framework for an "all-in" retail option, and financing the initial start up cost.

Council Member Woodards arrived here, at 12:25 p.m.

Mr. Dawson continued discussing options for "all-in" retail scenarios, including general assumptions, possible expansion of Centurylink, requirements, data, improvements, and risks and uncertanties.

Discussion ensued throughout the presentation regarding policy objectives, "all-in" options, fiber optic service, gigabit service, positive outcome from going "all-in" versus leasing, the triple play option, outsourcing, public outreach, state and federal law regarding utilities, restrictions on commission

based employees, subsidization, cost allocations, the wholesale option, and economic development.

Mayor Strickland requested a comparison between potential cost allocations for "all-in" and status quo scenarios. Board Member Larkin provided background information on the history of Click! Network.

Discussion continued regarding what option is best for Tacoma, purchasing internet service providers, assumptions, competition, values, and equal access.
