

ORDINANCE NO. 28909

AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the Tacoma Municipal Code to implement rates of pay and compensation for employees represented by the International Brotherhood of Electrical Workers, Local 483, Tacoma Power Unit, and the Professional and Technical Employees, Local 17, and declaring the effective dates thereof.

BE IT ORDAINED BY THE CITY OF TACOMA:
