## ITEM/ISSUE PROPOSED FOR COUNCIL CONSIDERATION:

I ask for your support for the inclusion of the following item on the agenda at the earliest available meeting of the Study Session:

I respectfully ask for City Council concurrence to allocate \$10,000 from the City Council Contingency Fund for the Latino Roundtable Community Convenings occurring in March 2016.

## **BRIEF BACKGROUND:**

In 2015, the City Council passed a resolution designating Tacoma as a member of the Welcoming Cities and Counties Initiative, which encourages communities across the United States to create more welcoming, immigrant friendly environments that maximize opportunities for economic growth and cultural vitality.

Strong interest among our Latino residents and community partners led to the creation of a community-run planning committee that will host two large convenings in March. These events will provide an opportunity for our Latino residents to share their vision for how their community can grow and thrive in Tacoma and Pierce County. It will also give them the chance to inform the City, local service providers and other residents about barriers they are encountering in their daily lives and how we can better engage with and provide better service to them. This event aligns strongly with our efforts to advance equity in Tacoma and this funding would be the City's first substantive action under the Welcoming Cities Initiative.

FUNDING REQUESTED: \$10,000 be set aside for City Staff to pay for expenses related to the convening
