

ORDINANCE NO. 29017

AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the Tacoma Municipal Code to implement rates of pay and compensation for employees represented by the District Lodge No. 160, on behalf of Local Lodge No. 282, of the International Association of Machinists and Aerospace Workers, Wastewater Treatment Plan Supervisors Unit; the Professional and Technical Employees, Local 17 (PROTEC17), Tacoma Police Department Non-Commissioned Management Unit; and the International Brotherhood of Electrical Workers, Local 483, Supervisors' Unit, and declaring the effective dates thereof.

BE IT ORDAINED BY THE CITY OF TACOMA:
