SUMMARY AND PURPOSE:

The City of Tacoma is participating as a Party to litigation with opioid Distributors and Pharmaceutical Supply Chain Participants alongside the State of Washington and 33 of its local political subdivisions, including counties and cities and towns with a population of over 10,000.

The Opioid Litigation is expected to result in settlements and/or judgments with direct money payments to the City of Tacoma and other Parties to the litigation.

In order to comply with the One Washington Memorandum of Understanding (One WA MOU), Pierce County has been designated as a region and must form an Opioid Abatement Council (OAC) to fulfill auditing functions for spending of Opioid Litigation settlement funds.

In order to receive settlement funding, each Party must sign onto the OAC Interlocal Agreement, and has the opportunity to select a representative to serve as a Council Member to the PCOAC.

BACKGROUND:

This Department's Recommendation is Based On:

As stated in the One Washington Memorandum of Understanding between Washington Municipalities, the people of the State of Washington and its communities have been harmed by entities within the Pharmaceutical Supply Chain who manufacture, distribute, and dispense prescription opioids.

The State of Washington and certain Local Governments, including Tacoma and Pierce County, are engaged in litigation seeking to hold these entities within the Pharmaceutical Supply Chain of prescription opioids accountable for the damage they have caused to community members and Local Governments.

Local Governments and elected officials share a common desire to abate and alleviate the impacts of harms caused by these entities within the Pharmaceutical Supply Chain throughout the State of Washington, and strive to ensure that principals of equity and equitable service delivery are factors considered in the allocation and use of Opioid Funds.

By signing onto this ILA to create an OAC, the City of Tacoma is fulfilling the requirement of the One WA MOU and creating the conditions to receive the Opioid Litigation funding.

It should be noted that signing onto this OAC ILA fulfills the auditing requirement of the One WA MOU, but does not determine or influence how the City of Tacoma may ultimately choose to use Opioid Litigation funds.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Tacoma residents have consistently asked the City for improved responses to the many impacts of the opioid crisis. Residents have consistently asked for the City to do more about drug abuse issues throughout the community, especially with youth and residents experiencing homelessness. This input has been heard through processes about the biennial budget, the community survey, and engagement around specific projects and issues around the city. This input has also impacted City of Tacoma responses, including the implementation of additional treatment service options and the development of a Behavioral Health Crisis Response Team within the Tacoma Fire Department. Additional resources to develop or expand new responses to the Opioid crisis will directly respond to community feedback and engagement.

Additional community engagement will be done in the next phases of this litigation process, which will focus on best uses of the funding within the allowable uses of the litigation agreement.

Although the opioid epidemic takes many shapes and forms, those most impacted by the opioid epidemic are often those who have the fewest resources and supports to successfully recover. We also know that opioid abuse is often related to trauma, and that communities that experience trauma disproportionately are also disproportionately at risk of opioid abuse. For these reasons, short-term actions to address opioid abuse do not adequately get at the need for upstream, preventative investments to improve the conditions that lead to negative health outcomes, including opioid abuse. In the cases of both immediate action and longer-term preventative work, the City maintains a strong commitment to continuing to approach the work with an anti-racist lens.

Improve health outcomes and reduce disparities, in alignment with the community health needs assessment and CHIP, for all Tacoma residents

Increase positive public perception of safety and overall quality of life.

Better addressing the impacts of the opioid crisis will both improve the health of those who are struggling with opioid abuse, but will also positively impact the health of their families. This includes the potential to reduce Adverse Childhood Experiences (ACEs), which have a significant negative impact on health. Additionally, helping people address opioid abuse will improve perceptions of public safety and quality of life, especially when considering the impacts we could make with regard to addressing co-occurring disorders amongst residents experiencing homelessness.
