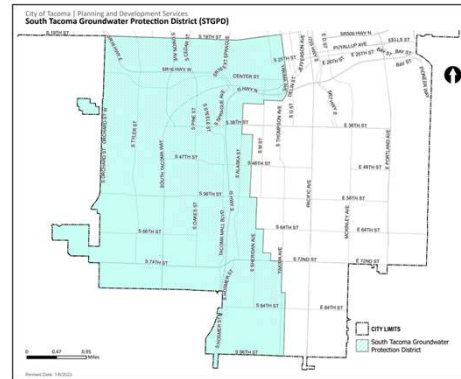

STGPD Background

- Created in 1988, prior to the State's establishment of the Growth Management Act (GMA) and its guidance on Critical Aquifer Recharge Area (CARAs)
- **Purpose:** protect aquifer drinking water from contamination
- **Key Regulations in STGPD:**
 - Applies to businesses and commercial uses
 - Prohibits incompatible land uses
 - Establishes standards for:
 - Hazardous substance storage
 - Stormwater infiltration
 - Spill prevention
 - Inspections, testing and enforcement
- **Lead agencies:**
 - Tacoma-Pierce County Health Department (TPCHD)
 - Tacoma Water
 - Environmental Services
 - Planning and Development Services (PDS)

STGPD Moratorium

1. Amended Substitute Resolution No. 40985

- Initiated moratorium review
- Adopted STGPD Work Plan

2. Adoption: On March 7, 2023, the City Council passed Ordinance No. 28872, enacting a moratorium within the STGPD as recommended by the Infrastructure, Planning, and Sustainability (IPS) Committee.

- **Uses Temporarily Prohibited:**
 - Underground Storage Tanks
 - Metal recycling/auto wrecking
- **Existing Uses:**
 - Prohibit expansion of existing facilities
 - Allow normal maintenance, repair, replacement activities, and existing operations
 - Allow site and facility improvements to comply with building code, stormwater, and environmental standards
