1 A RESOLUTION setting Tuesday, May 19, 2020, upon completion of Regular
2 Agenda Items, no earlier than 5:15 p.m., as the date for a public hearing by
3 the City Council on the submittal of the 2020-2024 Consolidated Plan to the
4 U.S. Department of Housing and Urban Development, for Housing and
5 Community Development.

6 WHEREAS the Consolidated Plan for Housing and Community
7 Development consists of a five-year Housing and Community Development
8 Strategic Plan and Annual Action Plan, which combines the submission of
9 applications for Community Development Block Grant ("CDBG"), HOME
10 Investment Partnership ("HOME"), and Emergency Solutions Grant ("ESG")
11 funding, and

12 WHEREAS, every five years the City submits a Consolidated Plan to the
13 U.S. Department of Housing and Urban Development ("HUD") in order to fulfill
14 the requirements associated with receipt of entitlement funding, and

15 WHEREAS the Annual Action Plan outlines the uses of CDBG, HOME,
16 and ESG funds, and

17 WHEREAS, before submission of the Annual Action Plan to HUD, the City
18 must fulfill certain citizen participation requirements, including accepting public
19 comment on the proposed plan, and

20 WHEREAS extensive community engagement efforts have been
21 conducted, including presentations at five Neighborhood Councils, the Planning
22 Commission, the Human Services Commission, the Human Rights Commission,
23 and the Hilltop Action Coalition, and distributing a survey to all attendees (also
24 accessible on-line for several weeks), and

WHEREAS the draft Annual Action Plan will be available for public review for a period of 30 days, beginning April 18, 2020, and ending May 18, 2020; Now, Therefore,

Section 1. That Tuesday, May 19, 2020, upon completion of the Regular Agenda items, no earlier than 5:15 p.m., is hereby fixed as the time and date, for a public hearing to be held on the submittal of the 2020-2024 Consolidated Plan to the U.S. Department of Housing and Urban Development, for Housing and Community Development; only written comments will be accepted for this public hearing, which is compliant with Governor Jay Inslee’s emergency proclamation issued March 24, 2020, and recently extended, suspending portions of the Open Public Meetings Act through May 31, 2020.

Section 2. That the City Clerk shall give proper notice of the time and date of said hearing or time for comment.
