Government Performance and Finance Committee (continued from the October 17, 2017 meeting)

Council Member Lonergan, Chair of the Government Performance and Finance Committee, stated the meetings of September 6, September 20, and October 4, 2017, were all cancelled. He reported the Committee met on October 18, 2017 and received reports on the 2016 Comprehensive Annual Financial Review, and the 2016 State Auditor's Office Federal and Financial Audit Exit Conference from the Finance Department. He stated the next meeting is November 1, 2017, and will include interviews for the Board of Ethics and updates on telecom franchise agreements.

Infrastructure, Planning, and Sustainability Committee

Council Member Mello, Chair of the Infrastructure, Planning, and Sustainability Committee, stated on September 27, 2017 the Committee held interviews for the Transportation Commission and received briefings on the parking initiative and model traffic ordinance. He reported on October 11, 2017, the Committee received a report on the Office of Environmental Policy and Sustainability's proposed Biogas project, and an update from Planning and Development Services on the 2018 Amendments and their work program for the coming year. He stated the next meeting is tomorrow and will include updates on the Unified Development Code, Puyallup Avenue Corridor Conceptual Design, the future plan between the City and Metro Parks for enhancements along Ruston Way, and the Regional Climate Change Pledge.
