SUMMARY:

Lightspeed Networks (LSN) is seeking a 10 year Limited Area Franchise to install approximately 505 linear feet of underground fiber optic cable to increase their connectivity and transport services to all major national wireless communication service providers.

BACKGROUND:

LSN is one of the Pacific Northwest region's fastest growing telecommunications companies, providing integrated telecommunication solutions to carriers, education, enterprise business and government customers. These solutions include advanced network transport, access, and productized services in major cities and rural communities throughout Oregon and Washington.

LSN entered into negotiations with the City of Tacoma seeking a 10 year Limited Area Franchise. Negotiations were handled in a very thorough yet responsive manner and both sides have come to agreement. Staff will seek a "do pass" recommendation from the Government Performance and Finance Committee on October 2, 2013.

ISSUE:

LSN needs access to the City of Tacoma Right of Way to complete this installation and they have agreed to the terms and conditions set forth in the Limited Area Franchise agreement before you for your consideration.

It is our (Jeff Capell, Legal and Jeff Lueders, MCO-Franchise Services) recommendation that the City Council approve this Limited Area Franchise Agreement allowing Lightspeed Networks access to our City of Tacoma Right of Way per the terms and conditions outlined in this agreement.
