# Homeless Strategy Alignment


## Washington State's 5-year Strategy

- Objective 1: Promote an equitable, accountable and transparent homeless crisis response system
- Objective 2: Strengthen the homeless service provider workforce
- Objective 3: Prevent episodes of homelessness whenever possible
- Objective 4: Prioritize those with the most significant barriers to housing stability and the greatest risk of harm
- Objective 5: Seek to house everyone in a stable setting that meets their needs

# City of Tacoma's 5-year Strategy

- Goal 1: Ensure affordable housing is available and accessible to Tacoma residents
- Goal 2: Everyone experiencing homelessness in Tacoma, or impacted by homelessness, can access services and support
- Goal 3: The shelter system in Tacoma offers Tacoma residents a safe and dignified experience that is easy to access.
- Goal 4: Tacoma homeless service system provides households with access to a continuum of tailored supports to prevent and end homelessness.
- Goal 5: Tacoma's homeless service system provides households with access to permanent, stable housing

# 2024 Highlights

### Goal 1: Ensure affordable housing

- Earmarked a portion of new or expanded funding that will provide support services in new development (Objective 1.3)
- Leveraged public and partner-owned land for affordable housing (Objective 1.1)

### **Goal 2: Access services and support**

- Created a "By-name List" (Objective 2.2, 2.3)
- Created and implemented outreach processes and capacity that allowed for on-demand services (Objective 2.2)
- Directly funded expansion of detox center for immediate access to treatment (Objective 2.3)

# 2024 Highlights

### Goal 3: Shelter system offers a safe and dignified experience

- · Published daily, weekly, and monthly reports for shelter bed utilization, capacity, and availability (3.1)
- · Increased shelter staff workforce by funding training academy (Objective 3.2)

#### **Goal 4: Continuum of tailored supports**

- Prioritized funds that provided tailored interventions that reduce racial disparities (Objective 4.1, 4.2)
- Collected data and disaggregated racial demographics that collaborate with other supportive systems (Objective 4.1, 4.2)
- Invested in direct MHSUD interventions that met best-practice standards (Objective 4.1)

#### Goal 5: Access to permanent, stable housing

- Invested Permanent Supportive Housing services to support new units (Objective 5.1)
- Supported existing service and shelter providers in their transition to providing housing and housing services to maintain continuum of care (Objective 5.2, 5.3)

# **Summary of Measurements**

### Point-in-Time Count

The Point-in-Time count continues to clarify an overall year to year trend of people who are experiencing homelessness

### **Homeless Management Information System**

This tracking is entered by all shelter providers and needs less active management while still giving a window into the number of individuals experiencing homelessness and there is some consistency in data input.

## **By-Name List (Preferred Method)**

A universal by name list has been proposed by the Pierce County Comprehensive Plan to End Homelessness and has been discussed with jurisdictions to align in practice on how to accurately count people who are experiencing homelessness. This list would include all people who are experiencing homelessness in Pierce County who stay in a shelter, work with an outreach provider, and include anyone who is included in our response system.





# By-Name List List Management



#### **Active Status (last 6 months)**

- People new to Homelessness
- · People who are returning to homelessness from housing
- · People who are returning from inactive status

### **Inactive Status (last 6-12 months)**

· People who have not been in contact with the response system

#### No Longer on the List

- · Archived: people who have not been in contact with the response system longer than 12 months
- Exited homelessness into permanent housing through the response system
- · Exited response system without assistance from the response system

- Continue to work with local stakeholders to collaborate and develop solutions for supportive housing units in Tacoma/Pierce County (Objective 2.4) (WHHSP Objective 5)
