# **Briefing Items**

2. <u>16-1242</u> South Sound 911 and County Properties Update [Martha Anderson, Assistant Director, Community and Economic Development]

At approximately 10:07 a.m., Martha Anderson, Community and Economic Development, provided a brief overview of the Public Safety Communications Center and Pierce County land holdings and introduced Andrew Neiditz, Executive Director, South Sound 911 and Bret Carlstad, Director, Pierce County Department of Facilities Management. Mr. Carlstad discussed

Pierce County land holdings, including background information and site overview. Mr. Neiditz discussed the Public Safety Communications Center, including background information, purpose, site area, and the approved Pierce County Resolution No. 2016-149. Mr. Carlstad reviewed the targeted schedule moving forward, additional Pierce County land holdings, and the deferred maintenance report.

Discussion ensued regarding the bid packaging, contractor bidding and awarding process, total investments, building elements directed for the design team, urban design, employment, neighborhood, economic development benefits, parking, security fencing, single and two story options, commercial space available, additional opportunities, and the Lincoln Business District.

3. <u>16-1243</u> Update on Economic Activity in Neighborhood Business Districts [Shari Hart, Program Development Specialist, Community and Economic Development]

At approximately 10:46 a.m., Shari Hart, Community and Economic Development, provided an overview of economic activity in Neighborhood Business Districts, including a status report on the Economic Development Strategic Framework Plan. She discussed retail, environment, adaptive reuse and infill development, and concluded by discussing additional development in the works.
