Briefing Items

Climate Action Plan Update

[Jim Parvey, Environmental Policy and Sustainability Division Manager, Environmental Services; Kristi Lynett, Sustainability Officer, Office of Environmental Policy and Sustainability]

At approximately 4:32 p.m., Jim Parvey, Environmental Policy and Sustainability Division Manager, Environmental Services, introduced Kristi Lynett, Sustainability Officer, Office of Environmental Policy and Sustainability, and Clark Mather, Community and Government Relations Manager, Tacoma Public Utilities (TPU). Together, they presented the Climate Action Plan (CAP) update, including the climate emergency; background; the City leading by example; climate action progress, noting General Government fleet vehicles, the Tacoma renewable natural gas plant, trees planted through the Grit City Trees program in the Tacoma Mall neighborhood, and active transportation; TPU climate action progress; status of the ten 2022 jump-start actions; CAP facts; and next steps and opportunities.

Discussion ensued throughout regarding Level 3 or "fast charge" electric vehicle charging stations in the City, public availability of chargers, grant funds received from the federal government and grants the City applies

for, how much money the City dedicates to the CAP, upcoming budget requests, the jump-start actions, the green economy study, partnering with WorkForce Central, and the timeline of the decarbonization studies.
