#### **Briefing Items**

1. <u>15-0150</u> Washington State Department of Transportation Amtrak Station Update

At approximately 12:03 p.m., Ian Munce, Planning and Development Services, introduced Ron Pate, Washington State Department of Transportation (WSDOT) Rail Division Director. Mr. Pate gave brief remarks and introduced David Smelser, WSDOT Capital Development Program Manager.

Council Members Ibsen and Thoms arrived here, at 12:05 p.m.

Mr. Smelser provided an update on the Amtrak Station at Freighthouse Square, including an overview of the Tacoma Point Defiance Bypass project, participants in creating the station plan, examples of before and after features of Freighthouse Square, examples of comments received, and concluded their presentation by showing a brief promotional video. Discussion ensued regarding design, concerns, quiet zones, and crossover between platforms.

Josh Diekmann, Public Works, presented an overview of the East 25th one-way conversion, including the study area and findings, community and stakeholder engagement, and next steps. Discussion ensued regarding parking stalls, design of one-way system and renderings.
