Briefing Items

2. <u>23-0226</u> Moss Adams 2022 Entrance Conference [Olga Darlington, Partner, Moss Adams]

At approximately 10:05 a.m., Olga Darlington, Partner, Moss Adams LLP, provided opening remarks and presented the 2022 audit entrance conference.

Board Member Claus-McGahan arrived here, at 10:06 a.m.

Darlington continued by reviewing an agenda; the 2022 Service Team leads; scope of services, noting an annual audit and limited procedures; audit deliverables; responsibilities; consideration of fraud in a financial statement audit; the audit timeline; and recent accounting developments from 2022 and future accounting developments for 2023-2024, noting Governmental Accounting Standards Board (GASB) statements.

Discussion ensued regarding the agreed upon procedures and report to the Environmental Protection Agency relating to the Thea Foss Waterway, noting what the report addresses.

Board Member Ball arrived here, at 10:16 a.m.

Discussion continued regarding the consideration of fraud in a financial statement audit, noting irregularities versus material misstatements; the expected date to receive the auditors report; GASB Statement No. 87, noting the purposed and impacts of the change; the State Auditor's Office audit

versus the Moss Adams audit; if it's common practice for cities to contract with a third party to handle part of the audit process; the total cost of the contract for auditing services; GASB Statement No. 96, noting examples of the changes; and GASB Statement No. 101, noting tracking potential compensated absences and liability.

3. <u>23-0227</u> Amendments to Tacoma Municipal Code 6A.130 [Danielle Larson, Tax & License Division Manager, Finance]

At approximately 10:27 a.m., Danielle Larson, Tax and License Manager, Finance, presented the proposed amendments to Tacoma Municipal Code Chapter 6A.130, relating to Local Solid Waste Customer Excise Tax, including an overview, background, issues, proposed revisions, recommendations, and next steps.

Discussion ensued regarding the exemption of collecting taxes for both public and private disposal services facilities, taxes that private haulers collect and how the City receives that money, how Schnitzer Steel would be charged, and if tree trimmings would be exempt from the tax.

MOTION: Vice Chair Bushnell moved to forward the proposed amendments to Tacoma Municipal Code Chapter 6A.1306A.130, relating to Local Solid Waste Customer Excise Tax, to the full City Council for consideration.

SECONDED BY: Council Member Rumbaugh.
