Chamber of Commerce Business and Industry Panel - 2023 Business Climate Survey [Carol Wolfe, Division Manager, Community and Economic Development; Andrea Reay, President, Tacoma Pierce County Chamber of Commerce]

At approximately 10:11 a.m., Chair Blocker provided opening remarks regarding the business and industry panel, noting it is a continuation from a panel discussion held at the May 9, 2023, Committee meeting; and expressed appreciation for the Tacoma Pierce County Chamber of Commerce (Chamber) and the panelists. The panelists introduced themselves, including Andrea Reay, Chamber; Cassandra Williams, Love By The Slice; Isaac Miller, Theory Real Estate; Katherine Raz, The Fernseed; Umi Wagoner, ETC Tacoma; and Justin Everman, McKinley Hill Business Association, and LUX Perpetua Coffee.

Discussion ensued throughout regarding how the city can improve communication; better support for local businesses; how to conduct community outreach; safety for the neighboring businesses; strengthening two-way communication programs; connecting better with people doing business within the City; support for people establishing a business, noting the need for guidance to help small business owners understand requirements and permit language; hurdles with getting a business up and running, noting fees, regulations, business and building costs, and application requirements; support for small and medium sized businesses; the role of the Chamber; addressing homelessness; transit; housing; parking; economic development; collaboration between business owners; impacts of Seattle's economy; submitting complaints; and next steps to address business owners' concerns.
