



# ORDINANCE NO. 28879

1 AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the  
 2 Tacoma Municipal Code, to implement rates of pay and compensation for  
 3 employees represented by the International Brotherhood of Electrical  
 4 Workers, Local 483, Clerical Unit; and to create the non-represented  
 5 classifications of Community Service Officer and Labor Negotiator, Public  
 6 Safety; and declaring the effective dates thereof.

BE IT ORDAINED BY THE CITY OF TACOMA:

7 Section 1. That Section 1.12.355 of the Tacoma Municipal Code (“TMC”) is  
 8 hereby amended, effective as provided by law, to read as follows:
