COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee.

Council Member Lonergan stated the Committee has met once since the last report and at that meeting the Committee heard recommendations from the Fiscal Sustainability Task Force; and heard a presentation from the Planning and Development Services Department on entering into a professional services agreement with Accela, Inc. for new permitting software. He stated the next meeting is scheduled for December 18, 2013, and the Committee is scheduled to conduct interviews for the Charter Review Committee and to hear about an amendment to the Zayo Telecommunications Franchise agreement.

Mayor Strickland discussed the upcoming Charter Review process, which occurs every ten years. She noted tomorrow, December 4, 2013, is the deadline for applications for those interested in serving on the Charter Review Committee.

Council Member Boe stated there is a broomball tournament tonight at Polar Plaza at 8:00 p.m. He also announced several upcoming events on Saturday, December 7, 2013, including Holiday Fest in the Proctor District, a Victorian Holiday Celebration at WW Seymour Conservatory at Wright Park, and a 19th Century Christmas event at Fort Nisqually in Point Defiance Park. He then stated the Pacific Avenue Streetscape Project is coming to an end and invited all to attend the "Pac the Ave" event on Pacific Avenue, on Saturday, December 7, 2013 from 3:00 to 5:00 p.m.
