REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated the City and the Port of Tacoma are holding an open house for the Port of Tacoma Road Reconstruction Project on Tuesday, May 26, 2015 from 11:30 a.m. to 1:30 p.m. at the Fabulich Center located at 3600 Port of Tacoma Road, in Room 104. He then stated the project team will provide information about the schedule and components of the project, as well as how traffic will be detoured during the repairs to keep terminals and businesses open. Mr. Broadnax noted grants were acquired for the reconstruction of 7,800 feet of the road surface on Port of Tacoma Road between 11th Street and Marshal Avenue, and renovations begin Sunday, June 1, 2015. He concluded by noting there is an estimated six-month project time line, and the City will post weekly schedule updates to the project on the City's website.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Public Safety, Human Services, and Education Committee

Council Member Woodards, Chair of the Public Safety, Human Services, and Education Committee, stated the Committee heard presentations on April 9, 2015 regarding the adoption of the Region 5 All Hazards Mitigation Plan for emergency management planning and mitigation funding, and the Human Rights Commission 2015 work report and work plan. She then stated the April 23, 2015 meeting included interviews for the Human Rights Commission and Human Services Commission. She concluded by noting the next meeting is scheduled for May 28, 2015, with presentations from three charter schools scheduled to open in Tacoma, including Green Dot, SOAR Academy Public Charter School, and Summit Public School.

Deputy Mayor Boe provided information on bike month events, including Bike to a Better Pierce County, the Mountain Biking Work Party at Swan Creek, the Bike Train: Downtown to King's Books, the Tweed Ride, and the Anderson Island Ride. He then provided information regarding the History Awards at the Foss Waterway Seaport; and arts events, including Crafts of the Past – Native American Basketry by the Fort Nisqually Foundation, Buddy – the Buddy Holly Story at the Tacoma Musical Playhouse, and Shirley Klinghoffer – CRT Revisited at the Museum of Glass. Deputy Mayor Boe concluded by stating the May 26, 2015 City Council study session and business meeting have been cancelled and the next regularly scheduled meetings will be held on June 2, 2015.
