## 2022-2023 ANNUAL ACTION PLAN



- Outlines the spending plan for **estimated** 2022-2023 formula grants from the federal Department of Housing and Urban Development (HUD)
  - Community Development Block Grants (CDBG): **\$2,460,177**
  - Emergency Solutions Grants (ESG): **\$215,615**
  - HOME Investment Partnerships Program (HOME): **\$1,410,150**
- Funds support community and economic development, housing, and public services programs
- Programs serve individuals, households, and business owners who earn 80% or less than Pierce County Area Median Income
- **Submission of the Plan to HUD no later than May 15, 2022**

- Fall 2021 – Planning initiated
  - Overview of planning timeline published online
  - Community meeting to provide overview of funding opportunities
- Winter 2022 - Funding recommendations made by:
  - Tacoma Community Redevelopment Authority
  - Human Services Commission in consultation with the Tacoma Lakewood Pierce County Continuum of Care
- Spring 2022 - Community Vitality Safety Committee City Council Study Session
