# **Briefing Items**

1. <u>23-1213</u> Proposal to Amend Chapter 8.17 Tacoma Municipal Code - False Reports of Crime

[Keith A. Echterling, Deputy City Attorney, City Attorney's Office]

At approximately 4:33 p.m, Keith Echterling, Deputy City Attorney, City Attorney's Office, presented the proposal to amend Chapter 8.17 of the Tacoma Municipal Code related to False Reports of Crime, including an agenda; overviews; issues; proposed revisions; and next steps, noting the Washington State law safe harbor provision for correct use of 911.

Discussion ensued throughout regarding 911 call types, how crimes are reported, the Tacoma Fire Department Cares Program, ambulance usage, and criminal prosecution.

MOTION: Council Member Rumbaugh moved to forward the proposed amendments to Chapter 8.17 of the Tacoma Municipal Code relating to False Crime Reports to the full City Council for consideration.

2. <u>23-1214</u> Rental Housing Code Additional Research Work Plan

[Ted Richardson, Strategic Initiatives Coordinator, Office of Strategy]

At approximately 4:51 p.m., Ted Richardson, Strategic Initiatives Coordinator, Office of Strategy, and ChiQuata Elder, Senior Equity Programs Consultant, Office of Equity and Human Rights, presented the Rental Housing Code (RHC), including the background; timeline; considerations; research questions with overlapping details for winter weather eviction ban; school year eviction ban, the economic displacement relocation assistance; pet fees, rent, and deposits, and move in fees and deposits.

Discussion ensued regarding winter weather eviction, eviction types, school year eviction ban, and the economic replacement relocation assistance program.

MOTION: Chair Ushka moved to prioritize for further study into three phases;

Phase 1: Item No. 6 (income to rent ration) and Item No. 8 (digital legal notices and tenant information packets);

Phase 2: Item No. 10 (winter weather eviction ban), Item No. 11 (school year eviction ban), Item No. 13 (economic displacement relocation assistance); and

Phase 3: Item No. 1 (pet fees, rent, and deposits), Item No. 5 (move in fees and deposits).
