# FOR THE GOOD OF THE ORDER

- 1) Jacinda Howard provided the Board an update on the schedule for accepting applications for board members to fill vacant positions for one CPA, one construction/developer, and one real estate position. A timeline for electing new board officers was also presented.
- 2) Jacinda Howard reminded the Board that they will hear oral presentations from 2016- 2017 CDBG applicants on Feb. 11, 2016 and that the meeting will run longer than typical regularly scheduled meetings.
- 3) Jacinda Howard let the Board know that HomeStreet Bank has accepted an offer for \$3.2 million on the property located at 2645 S. 80<sup>th</sup> St., Tacoma. The Board will be further updated on this matter at a later date.
- 4) Jacinda Howard reported that small business loans that are in default are subject to a 12% interest rate and staff's standard practice is to make the borrower aware that their loan is in default and a 12% interest rate will be charged before charging the higher interest rate. The information was in response to a question posed by the board at the Jan. 14, 2016 board meeting.
