RECOMMENDATION SUMMARY: Community and Economic Development requests approval to increase Contract CW2255959 with Tacoma-Pierce County Bar Foundation d/b/a Tacomaprobono Community Lawyers, Tacoma, WA, by \$440,000, plus applicable taxes, budgeted from Landlord-Tenant Program 20910, for eviction prevention legal services. This increase will bring the contract to a cumulative total of \$802,328.97, plus applicable taxes.

STRATEGIC POLICY PRIORITY:

Ensure all Tacoma residents are valued and have access to resources to meet their needs.

BACKGROUND: Tacoma-Pierce County Bar Foundation d/b/a Tacomaprobono Community Lawyers provide eviction prevention services to tenants residing in rental property in the City of Tacoma since 2023. Focusing on traditionally marginalized communities, the following services are provided:

- Full, partial, or guided legal representation for the purposes of preventing eviction.
- Outreach events and legal clinics for the purposes of tenants' rights
- Housing resources and navigation services

ISSUE: The City currently lacks the necessary systems, processes, and staff to provide the legal assistance needed to represent tenants for eviction prevention services. The Tacoma-Pierce County Bar Foundation d/b/a Tacomaprobono Community Lawyers is the only organization inside the City providing no cost legal services to low-income tenants as part of the Tacoma-Pierce County Bar Foundation.

ALTERNATIVES: The City could decline continuing the contract and reallocate the \$440,000 budgeted for these services. However, this alternative would result in low-income tenants in the City not having access to no cost, dedicated legal eviction prevention services.

COMPETITIVE ANALYSIS: In the original contract, the City requested and was granted a Direct Negotiation waiver of competitive solicitation. Tacomaprobono Community Lawyers is a nonprofit group of community lawyers providing pro bono legal aid for Washington tenants facing eviction. There are no other providers with this level of service that the City is aware of.

CONTRACT HISTORY: This contract was originally awarded to Tacoma-Pierce County Bar Foundation d/b/a Tacomaprobono Community Lawyers as a result of Direct Negotiation in January 2023. The initial contract was from January 1, 2023, to December 31, 2023, in the amount of \$240,000. The termination date was extended from December 31, 2023 to

December 31, 2024, and compensation under the Contract increased by \$240,000 for a new not-to-exceed amount of \$480,000.

In this amendment the City recaptures \$117,671.03 of the \$480,000.00 allowable reducing the 2023-2024 contract value to \$362,328.97 and adds a \$440,000.00 for a new projected contract value of \$802,328.97.
