At approximately 12:49 p.m., Katie Johnston, Budget Officer, Finance, introduced Jared Eyer, Senior Management and Budget Analyst, Office of Management and Budget, and Chris Bandak, Executive Vice President of Market Research and Analytics, MDB Insight Inc., and together they presented the Community Satisfaction Survey, including the methodology; results for overall quality of life and satisfaction questions, noting quality of life and satisfaction with municipal services; results of quality of life and community questions, noting major issues facing Tacoma, social services, and crime and public safety; the satisfaction of services overview; satisfaction and importance; and improvements. They further reviewed results for municipal confidence and participation survey questions, noting government confidence, participation in events and civic life, service complaints, and community impact; key findings; and next steps.

Discussion ensued regarding quality of life, crime rates in Tacoma versus other municipalities, demographic representation, renter sampling versus owner sampling, and seeing trends from previous surveys.

## Other Items of Interest

Council Member Walker stated she will be bringing a Council Contingency Request for the University of Washington Tacoma Urban Studies Forum on Attainable Housing to next week's study session.
