**MOTION:** Matt LaCroix moved to approve the consent agenda. Dan Montopoli seconded the motion. The motion passed unanimously.

### **ADMINISTRATION**

4. Administrative Report Documentation (Presenter: Jacinda Howard)

Staff and the TCRA board discussed what documentation the board prefers to accompany the monthly administrative reports. The board unanimously decided it preferred to receive the full report, to include the summary and all copies of documents executed by the TCRA Administrator on behalf of the TCRA board, in Adobe PDF format. The PDF document will be sent to the board members electronically and will accompany the electronically distributed meeting agendas. 5. Election of Officers (Presenter: Jacinda Howard)

Staff distributed ballots to be used by TCRA board members to elect individuals to the officer positions of Secretary and Treasurer. Board members voted at the meeting. Tess Colby was unanimously elected to serve as the TCRA Secretary until her term expires on January 21, 2016. Jason Kors was unanimously elected to serve as the TCRA Treasurer until his term expires on January 21, 2016. A President was not elected as Curt Curtis will hold this position until his term ends on January 21, 2016. A Vice President was not elected as Steve Snider will hold this position until December 4, 2015. Officers assumed their positions immediately following the vote.

6. Reappropriation of HUD- Business Revolving Loan Fund (Presenter: Carey Jenkins)

Staff requested the TCRA board discontinue the HUD- Business Revolving Loan Program and reprogram the associated \$566,765 in Community Development Block Grant funds to a newly established Special Purposes Economic Development Revolving Loan fund.

MOTION: Michael McNiel moved to discontinue the HUD- Business Revolving Loan Program and reappropriate the associated funds to a Special Purposes Economic Development Revolving Loan fund. Matt LaCroix seconded the motion. The motion passed unanimously.

Staff provided a quarterly update for the period ending December 31, 2014 on the status of the 2014-15 Community Development Block Grant contractors.
