At approximately 10:04 a.m., Debbie Bingham, Program Manager, Community and Economic Development, introduced Clare Petrich, President, Tacoma Sister Cities Council. Together, they presented an overview, vision, photographs, active and semi-active Sister Cities, 2023 and 2024 funding for Tacoma Sister Cities Council, community accelerator grant, community partnerships and sponsors, 2023 activities, Fawcett Elementary is a Sister Cities School, events held, fundraising, what's coming in 2024, mission statement, upcoming events, and appreciation.

Discussion ensued regarding process of becoming a Sister City, opportunities for students, internship possibilities, government official exchange, state department involvement, port involvement, budget and funding, relationships with the cities, aligning goals with problem solving within the City, engagement with youth, connections, and appreciation for the Sister Cities Council and staff.

- 2. [24-0184](#) 2023-2024 Downtown Tacoma Partnership Update
[David Schroedel, Executive Director, Downtown Tacoma Partnership]

At approximately at 10:48 a.m., David Schroedel, Executive Director, Downtown Tacoma Partnership (DTP), presented on keeping downtown safe, clean, and welcoming, including a brief history, leadership and staff, and how the rate structure works; 2023 DTP safety report; 2023 DTP clean report noting, total trash and graffiti removals; DTP's goal to be welcoming, noting community channels; community events; store front openings and closings from 2020-2023; and headlines driving downtown, noting an increase in homicides throughout Tacoma.

Discussion ensued regarding expectations of the City and safety levels, graffiti, clean up crew, redesign for trash cans, grocery store downtown, membership structure, conflict resolutions, relationships with the City's alternative response teams, event funding, increase in crime, and budgeting.
