Chair Hines called the meeting to order at 10:01 a.m.

Briefing Items

Tacoma Public Utilities Cost of Service Analysis and Rate Design Results [Alex Yoon, Deputy Director, Tacoma Public Utilities; Jing Liu, Rates and Forecasting Manager, Tacoma Power; Daniel McCabe, Division Manager, Business Services, Tacoma Rail; Andrew Zaremba, Senior Utilities Economist, Tacoma Water]

At approximately 10:03 a.m., Jing Liu, Rates and Forecasting Manager, Tacoma Power; Daniel McCabe, Division Manager, Business Services, Tacoma Rail; and Andrew Zaremba, Senior Utilities Economist, Tacoma Water, presented the 2025-2026 Tacoma Public Utilities (TPU) cost of service analysis (COSA) and rate design results, including an explanation of what COSA and rate design is.

Zaremba, presented revenue requirements and cost of service, noting a 6.5 percent system average rate increase and revenue requirements and proposed annual rate adjustments by customer class; rate design, noting cost and revenue recovery structure; average residential monthly bill; comparative retail rates, noting 2024 regional comparison of average monthly bills and bills with and without Bill Credit Assistance Program (BCAP); and an update on

water service construction charges.

Liu, presented Tacoma Power's comparative retail rates, noting 2024 Western Washington monthly residential bill and comparison of average monthly bills with and without BCAP; proposed rate adjustments, noting 2025-2026 proposed annual rate increase; what is driving the rate increase, noting cumulative increases since 2019; peer utility rate increase; proposed updated residential rates, noting fixed and delivery charges; regular versus BCAP bills; and updating other rates and fees, noting transmission and distribution, electric vehicle public charging rates, and electro fuel (EF) rate schedules.

McCabe, presented on Tacoma Rail rates, including primary rate payers, noting revenue percentages; line haul railcars versus platforms; line haul rate analysis and volumes; preliminary rate impact, noting proposed line haul rates; rates over time, noting 2018 increase; and other tariff rates, noting Lakewood subdivision.

Discussion ensued throughout regarding Tacoma Water's 6.5 percent system annual average, cost increase per year, projection after the WestRock closure, rate design and revenue recovery, BCAP benefits, wholesale customers, variable costs, fixed rates, increased summer rate tiers, water surcharge update, and revenue streams; Tacoma Power's fees for electric charging, increase to distribution of transformer costs, re-licensing of the State dams, reconnection fee damage to EV charging stations, peer rate utility increases, Peninsula Light Company, Bonneville Power Administration contract, current rate of residential and commercial construction inspection fees, and EF rates; and Tacoma Rail's difference in markets, advantages for commercial and intermodal customers using our system, difference in delivery times between each market, line haul volumes, expansion of the number of customers, tariff comparison, and the past ten years of rates increases.
