4. Action Items

A. Siting of Tacoma Art Museum Artwork on Right of Way 5:07 pm (2:25)

Stephanie Stebich, Rock Hushka, and Alyce McNeil presented on the Street Occupancy Permit request to place artwork on public Right of Way in front of Tacoma Art Museum.

The two pieces that are proposed for siting on Right of Way are:

- Marie Watt "Blanket Stories: Transportation Object, Generous Ones, and Trek", two bronze arches cast from blankets.
- Scott Fife "Explorers", a 5' tall bronze bear and 3' tall bronze eaglet on a raft, to be sited where the current café patio is located.

Three additional pieces that are under development but will not be sited on Right of Way are:

- Julie Speidel "Kinetic Repose", ten stainless steel elements to be sited at the parking lot entry below the Museum.
- Jim Hodges A sculpture playing with a camouflage pattern to be sited outside of the Pacific Avenue entrance.
- Sharon Nelson A Coast Salish basket weaving design for the roof of the new building wing.

Risks that the Tacoma Art Museum is addressing and will assume include liability of climbing public artworks (attractive nuisance) and conservation/maintenance.

Commissioners asked clarifying questions.

5. Presentation

A. Sound Transit 66th Street Public Art Project 5:40 pm (35:42)

Claudia Riedener, Christopher Jordan, and Kenji Stoll presented their proposed public artwork for Sound Transit's 66th Street Trestle. The artwork will be a combination of ceramic relief tile and latex and aerosol paint mural with a design that helps reflect the diverse community needs of many generations of residents. The proposal is inspired by topographical maps, textures, layers of history, historic buildings, and flora of the area. Some of the tiles on the north and south walls will contain



stamped quotes that will be gathered from community members. The mural will be composed of bright and vibrant colors in a warm palette. The project should be completed by the end of summer.

Commissioners talked about the proposal and asked clarifying questions.

The PAVE Bell sculpture has be reinstalled along Ruston Way.

Sun King is scheduled to be installed by the end of the week. The artist, Thomas Morandi, will attend the dedication on June 25.

Work is under way to get the Water Forest up and running again back to its original repaired condition.

Artspace will come to Tacoma the week of June 23 to work with local developers who have viable artist live/work projects.

Metal-Urge planning is under way and venues will begin reviewing artist submissions tomorrow.

The Arts Program is managing a public art project for Tacoma Housing Authority's Bay Terrace development. Finalist artists will be interviewed for the project.

Work is under way to submit a Heritage Grant to create interpretive work for the Prairie Line Trail.

Metro Parks is potentially looking to implement a Percent for Art policy and looking at how that would be managed.

ArtsWA's Regional Arts Forum to welcome Karen Hanan was held in Tacoma on May 5.

Kim Bedier presented on the Warhol for the Tacoma Dome to the Economic Development Committee. The Dome will test out a 6' sample of the proposed product to see how it wears over time.
