COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Neighborhoods and Housing Committee

Council Member Walker stated that the July 6, 2015 meeting was a tour covering areas involved in the Tacoma Mall Subarea Plan led by Planning and Development Services and included staff from Code Enforcement, Community and Economic Development, and the Tacoma Police Department. She stated the Committee surveyed by bus and foot the Madison neighborhood, South 38th Street, and the Lincoln Heights Neighborhood. Council Member Walker stated that the discussion covered the impending planning process, history of the mixed use center concentrated growth and development areas, and the need to build amenities for the community. She continued her report stating that during the August 3, 2015 meeting was a debrief of the Tacoma Mall area tour and a discussion regarding the Affordable Housing Work Program and the plan components and recommendations from the Affordable Housing Policy Advisory Group.

Council Member Walker stated at the meeting yesterday there was a more expansive discussion of affordable housing especially in light of the recent articles and attention to the Comprehensive Plan and density recommendations that have been received. She stated the Committee was also updated on the proposed changes to the residential parking program. Council Member Walker stated the next meeting is September 21, 2015, and the Committee will discuss short term rentals, the Narrowmoor Conservation District, and will be given an update from Community Based Services. She then announced the September 7, 2015 meeting is cancelled due to the Labor Day holiday.

Council Member Campbell reminded everyone about the Eastside Farmers Market on Wednesday located at 44th Street and Portland Avenue and the Open House regarding the Lincoln District Revitalization Project on Thursday, August 20, 2015 at 6:30 p.m. at the Tacoma Pierce County Health Department's Auditorium. He stated the Open House will include presentations regarding the project from various departments of the City.

Council Member Woodards announced that the Imahe Dancers will present their 3rd Annual Recital on Saturday, August 22, 2015, at the Star Center at 5:30 p.m. as a fundraiser for their competition in Guam.

Council Member Walker announced two events on Saturday, August 22, 2015; the Hilltop Street Fair in People's Park, which will include the Hilltop Hero's Award at 2:00 p.m., and the Tacoma Housing Authority's 75th Anniversary on L Street at noon.

Council Member Ibsen stated that the next public forum to discuss the Integrated Resources Plan for Tacoma Public Utilities, which is the long-term energy portfolio and how it is carried out through Tacoma Power, will be held on Wednesday, August 26, 2015 from 2:00 p.m. to 5:00 p.m. at Tacoma Public Utilities.
