Chief Green introduced Bruce Bouyer, Deputy Chief, and Mary Hallman, Assistant Chief, TFD; and presented the TFD departmental highlight, including how the workforce reflects the community, noting the

racial and demographic diversity of TFD employees. Bouyer further presented how the workforce reflects the community, noting efforts taken to increase diversity and eliminate barriers. Hallman reviewed the purposeful outreach and engagement, noting an example of continuous quality improvement efforts of identifying areas of need based on cardiopulmonary resuscitation (CPR) data and targeting those communities with more training, citizen CPR rates by race, and the need to increase CPR education to the public. Chief Green further reviewed the purposeful outreach and engagement, noting four committees that he established, three of which are internal, including details of the one external committee entitled Community Advisory Committee; and described the equitable service delivery. Bouyer continued by outlining the departmental look forward, noting upcoming events, programs, and increased roles with the Community Advisory Committee. City Manager Pauli concluded by presenting recent accomplishments, upcoming community engagements, and the transformation timeline and history.
