TPD Crime Reduction Plan

- 6:08pm Deputy Chief Junger gave an overview of Tacoma Police Departments' new Crime Reduction Plan.
 - o Reports that both crime and complaints are down from the same time last year.
 - Crime hotspots disproportionately around businesses and shopping centers, these are the focus of the first 90 days of the Crime Reduction Plan.
 - In later phases TPD will look for businesses willing to employ people exiting incarceration.
 - After first 90 days the academia that helped develop the plan will present to City Council
 on the progress of the Plan to date.

Discussion on WA State Attorney General's Model Use of Force Policy

- TPD has to draft and adopt the AG's model Use of Force Policy by December 2022. TPD is seeking CPAC's review of the policy.
 - The TPD policy can be more restrictive in certain regards, but not less restrictive.
 - o Following steps will be bargaining the policy with the police unions.
