#### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee

Council Member Lonergan, Chair of the Government Performance and Finance Committee, stated the Committee heard a presentation from Tacoma Public Utilities on the proposed water and power rate increases for 2015 and 2016, and recommended forwarding the proposed rates to the full Council for adoption. He then stated City Attorney Elizabeth Pauli presented on four ballot measures amending the City Charter passed by voters that needed Council action for implementation, noting the Committee discussed the measures and provided guidance on implementation. Chair Lonergan noted the Committee heard a presentation from Public Works on the Local Improvement District program, and from Information Technology on the City's Microsoft enterprise licensing agreement renewal. He then stated the Committee also reviewed the Committee's 2014 Year-End Report and discussed potential items for 2015. Chair Lonergan stated there was a special meeting of the Audit Advisory Board on January 21, 2015 to hear an audit entrance conference for the City's utilities and the results of the accountability audit report from the State Auditor's Office. He concluded by stating the next meeting will be March 4, 2015, and will include the Tacoma 24/7 2014 Year-End Report.

Deputy Mayor Boe provided information on a number of performing arts events in Tacoma, including the The Great Hall at Annie Wright School; the Oscars, Classics, and Cartoons by the Tacoma Concert Band at the Pantages Theater; Seussical TYA at the Tacoma Musical Playhouse; and the Tacoma Youth Symphony at the Rialto Theater.

Council Member Ibsen stated this Thursday Metro Parks Tacoma will host the second of four Destination Point Defiance town halls regarding the Point Defiance Park Master Plan, noting the meeting will focus on improvements to support facilities for the triangle area.
