Budgeted from ES Wastewater Fund 4300 Request for Bids Specification No. ES13-0515F

RECOMMENDATION: The Environmental Services Department recommends a contract be awarded to low bidder **Beaver Equipment Specialty Co., Inc., Kenmore, WA,** to provide 25 Rotork Actuators for the Central Wastewater Treatment Plant (Treatment Plant 1) Automation Project. The contract amount reflects a total award of \$235,108.00, plus applicable sales tax.

EXPLANATION: This contract is for the procurement of 25 Rotork Valve actuators for the automation of wastewater treatment plant processes at the Central Wastewater Treatment Plant (Treatment Plant 1). Performing this work will automate processes for more efficient operation of the treatment plant.

COMPETITIVE SOLICITATION: Request for Bids Specification No. ES13-0515F was opened December 03, 2013. Three companies were invited to bid in addition to normal advertising of the project. Two submittals were received. The table below reflects the amount of the base award.

The recommended award is 9.4 percent above the pre-bid estimate.

<u>SUSTAINABILITY FACTORS:</u> Utilizing Rotork valve actuators increases wastewater processing efficiency and effectiveness by enabling constant computer monitoring and control of process valves.
