City Manager T.C. Broadnax shared the City's new video for the 2015-2016 budget and encouraged citizens to attend the upcoming series of community budget input meetings.

## COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee.

Council Member Mello stated the Infrastructure, Planning, and Sustainability Committee recently interviewed applicants for the Sustainable Tacoma Commission and made five recommendations for appointment; heard an update on the 2014 annual amendments to Tacoma's Comprehensive Plan; participated in a walking tour of the low impact development project at Wapato Lake Drive; and discussed GreenRoads and green infrastructure implementation. He stated the Committee also received a progress report on the development of Tacoma's Transportation Master Plan and an update from Sound Transit on their long-range planning efforts; received a presentation on additions to Tacoma's heavy haul corridors; heard from the Washington State Department of Transportation about their upcoming construction project to expand and improve Interstate 5 between South M and East L streets; and heard about ongoing City construction projects and the Sustainable Materials Management Plan. He noted at the next meeting, the Committee will conduct interviews for the Transportation Commission and the Board of Building Appeals.

Council Member Walker thanked City Manager Broadnax for the first of the five community budget input meetings, and announced the community cleanup this Saturday in the Hilltop from 10:00 a.m. to 2:00 p.m., noting the drop-off location will be at Evergreen State College Tacoma campus.

Council Member Boe reminded everyone of all four of Tacoma Farmers' Markets: 6th Ave on Tuesdays, Broadway on Thursdays, Proctor on Saturdays, and South Tacoma on Sundays. He also announced the Saturdayz Flea Market, held every Saturday this summer on Antique Row.

Council Member Campbell announced the community cleanup in the First Creek and Dome Top neighborhoods this Saturday from 10:00 a.m. to 2:00 p.m., and the upcoming District 4 budget meeting scheduled for August 4, 2014.

Council Member Lonergan announced that from 10:00 a.m. to 2:00 p.m. this Saturday, July 19, 2014, at the Grocery Outlet at 56th Street and South Tacoma Way the Lincoln Boosters will hold a Family Fun Day complete with a bounce house, live music, family fun and entertainment, and football coach John Kitna.

Mayor Strickland reminded everyone to vote for Tacoma Fire Department's Station 12 team in Good Morning America's 5-Alarm Firefighters Challenge.
