#### REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated the Washington Industrial Energy Leaders Program is recognizing the City of Tacoma's Central Wastewater Treatment Plant with an award from Washington State Governor Jay Inslee for improved energy performance. He then stated in recognition of the International Date for the Elimination of Racial Discrimination on March 21, 2015, the Human Rights Commission and the Office of Equity and Human Rights are hosting a free community workshop in partnership with the Conversation; Tacoma Urban League; Northwest Sound Consulting; Solutions for Humanity, Community and the Environment; and the Russell Family Foundation Puyallup Watershed Initiative Social and Environmental Justice Community of Interest. Mr. Broadnax concluded by thanking the Council for their kind words tonight and feedback during the performance evaluation process, and acknowledging staff for their hard work.

#### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Deputy Mayor Boe provided information on arts events in the City, including Songs from the Emerald Isle by the Tacoma Symphony Orchestra, Pippi Longstocking by the Tacoma Musical Playhouse Family Theater, and the Spring Sing by the Puget Sound Revels at the B Sharp Café.

Council Member Walker provided information on her trip to Selma, Alabama, for the commemoration of the 50th anniversary of Bloody Sunday and the Selma-to-Montgomery March for voting rights, and noted events included crossing the Edmund Pettus Bridge, honoring a group of people that were at the march 50 years ago, and listening to a speech from United States President Barack Obama.

Council Member Woodards provided information on the crossing of the City's 11th Street Bridge to march in solidarity with the events happening in Selma, and thanked all those who organized and participated in the event.

Council Member Campbell provided information on community events in District No. 4, including the Urban Hike: Discovering Dometop on Foot event, and a town hall at Lincoln High School to discuss the City's Comprehensive Plan. He also noted the Washington State Department of Transportation will be closing the Pacific Avenue Bridge for one year beginning April 6, 2015.

Council Member Woodards provided information on the Cultural Grooming event by Washington Engage at Pacific Lutheran University, and the panel discussion on human trafficking and commercially sexually exploited children at the Women's History Month event held at the University of Washington-Tacoma.
