REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated the City has been awarded \$5 million in funding from the Puget Sound Regional Council for transportation projects.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Economic Development Committee

Council Member Campbell stated on October 14, 2014, the Committee interviewed and recommended one applicant to the City Events and Recognition Committee and received an informational briefing from the Broadway Center for the Performing Arts on their centennial fundraising campaign and renovation for needed facilities. He then stated on

October 28, 2014, the Committee interviewed nine applicants and recommended four of them to the Tacoma Arts Commission, received a briefing on plans for Tall Ships 2017, and heard an update on the Small Business Enterprise code and program extension. He stated at today's meeting the Committee received a briefing from the Foss Waterway Development Authority on the status of the esplanade and proposed agreement related to the marina lease and development contribution, which was recommended to the full Council. He noted the Committee also heard an 18-month review of the Community and Economic Development Department action plan and received a briefing on key economic indicators of the third quarter 2014. He added the next meeting will be December 9, 2014, and will include an update on the urban clean water innovation partnership zone, the disposition of tier one properties, and the patch test performed on the Tacoma Dome.

Council Member Boe provided information on a number of events happening in Tacoma throughout the holiday season, including Zoo Lights at Point Defiance Zoo and Aquarium, the annual tree lighting ceremony on Saturday outside of the Pantages, the Gingerbread Jamboree at the Childrens' Museum of Tacoma, the Polar Plaza ice skating rink at Tollefson Plaza, the Seattle Mens Chorus at the Broadway Center, the Christmas Revels at the Rialto, the Tacoma ballet production of the Nutcracker at the Pantages, and finally First Night to ring in the new year. He invited everyone to celebrate the holidays by attending all of the great events in Tacoma.

Council Member Campbell encouraged everyone to go local and shop from locally owned businesses rather than going to national chains.

Council Member Ibsen added there is a website called shop253.com where people can use a search engine to find local stores that may be selling the items people want to purchase and encouraged everyone to do their best to support local businesses during the holiday season and be safe.
