At approximately 10:04 a.m., Jeff Lueders, Cable Communications and Franchise Services Manager, Media and Communications Office, presented the new Comcast cable television franchise agreement, requesting consideration and approval of Ordinance No. 28900, including existing Comcast cable franchise, history of the renewal, negotiation teams, and key provisions of new franchise.

Discussion ensued regarding the letter of credit, right-of-way, provisions of the Tacoma Municipal Code needing to be followed, process going forward, utility taxes, telephone and cell phone tax, and General Fund dollars.

At approximately 10:24 a.m., Katie Johnston, Budget Officer, Office of Management and Budget, introduced James Osundwa, Division Manager, Information Technology (IT), and presented on the Open Data portal, including background, project objectives, project accomplishments, open data standards and procedures, making data findable, and next steps. Osundwa introduced Christina Chelf, Technology Manager, IT Geographic Information System Services, who presented the website demonstration for the new Open Data portal.

Discussion ensued throughout regarding completed policies, roles and responsibilities, connecting to the site, which departments are participating, accessibility for students, public outreach, press releases, Open Data updates and possible reduction on public disclosure requests, service level agreements, directing people to the site, the Open Data site displayed on the banner of the City of Tacoma site, partnerships to add information to the Open Data portal, what file types and dashboards are available and which ones can be created, and requesting that Council Members promote the site.

Council Member Hines discussed the process of the Public Utility Board interviews noting that there are seven applicants.


