REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated May 4-10, 2014 is Public Service Recognition Week and since 1985 the first week of May has been a time to set aside to honor the public servants who serve our nation as federal, state, county, and local government employees, and who work tirelessly on behalf of our citizens. He stated these employees do the work that keeps our nation and cities working and provide the diverse services demanded by the American people of their government with efficiency and integrity. He stated the theme of this year's recognition week is "Proud to Serve" and he wanted to take an opportunity to communicate the benefits and the value of the work that City of Tacoma employees do.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee.

Council Member Lonergan stated the Government Performance and Finance Committee has met once since his last report, and at that meeting, the Committee heard and forwarded recommendations to amend Chapter 12.13 of the Municipal Code regarding Click! Network Cable TV rates. He stated the next meeting scheduled for May 7, 2014, will be a joint meeting with the Audit Advisory Board and the Committee will have an audit entrance conference and an audit exit conference presentation. He noted the Committee will also hear a presentation on For-Hire Transportation Services.

Council Member Boe reminded us that Bike Month has started but it's not too late to register for the Bike Month commuter challenge at www.piercetrips.com. He then shared other Bike Month events, including Bike to School Day on May 7, 2014; the first Tacoma Tweed Ride on May 10, 2014; and the Cyclofemme ride on Mothers Day. He noted May is also Historic Preservation Month. He also stated the Grand Cinema is sponsoring a viewing party for its 72-hour Film Festival at the Urban Grace Church; the farewell concert for Tacoma Symphony maestro Harvey Felder will be held at the Pantages Theatre this weekend; and both the Tacoma Young Artists and the Hilltop Artists have events this weekend as well.

Deputy Mayor Woodards announced that Council Member Boe will lead an architecture walk, as part of the Walk Tacoma 2014 series, tomorrow, Wednesday, May 7, 2014 at noon.

Council Member Walker echoed the invitation to the Tacoma Symphony performance and the Cyclofemme ride meeting.
