REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated every two years the City of Tacoma participates in the State of Washington's Commute Trip Reduction survey that is administered by the Washington State Department of Transportation for worksites with 100 or more employees that report to work between 6:00 and 9:00 a.m. He stated this year General Government had a great response to the survey at 72 percent, and he thanked Employee Transportation Coordinators. He noted during 2013 there were approximately 1,100 ORCA passes distributed and more than 140,000 transit trips by employees.

Mr. Broadnax announced that two City initiatives have been recognized with 2014 Smart Communities Awards, the South Downtown Sub-area Plan, and the Interlocal Agreement between the City and the Port of Tacoma for shoreline public access. He stated additional information about these projects can be found on the Planning Division's website at cityoftacoma.org/planning.

Finally, he announced Public Works Fleet Services was ranked 21st this year in the top 50 Leading Fleets Award program by Government Fleet Magazine.
