SUMMARY AND PURPOSE:

An ordinance approving and confirming the Final Assessment Roll for Local Improvement District No. 8643, which provided for the construction of permanent pavement with storm drainage in the following locations:

- 1) Union Avenue from North 24th Street to North 25th Street northbound;
- 2) Washington Street from North 16th Street to North 18th Street;
- 3) Wapato Street from South 50th Street to South 51st Street; and
- 4) Huson Street from South 64th Street to South 66th Street.

BACKGROUND:

The Hearing Examiner's recommendation to confirm and approve the Final Assessment Roll for Local Improvement District No. 8643 ("LID 8643" or the "LID") is based on the evidence and testimony presented at the public hearing held on January 14, 2021. The construction of permanent pavement with storm drainage in Segment 1- Union Avenue from North 24th Street to North 25th Street - northbound; Segment 2- Washington Street from North 16th Street to North 18th Street; Segment 3- Wapato Street from South 50th Street to South 51st Street; and Segment 4- Huson Street from South 64th Street to South 66th Street, has been completed in accordance with the plans and specifications for the work. The final project cost is \$1,178,888.37 which consists of \$191,069.65 being assessed to property owners. The City contributed \$663,699.54 to the total project cost. The LID is intended to be a 10-year assessment roll and the final assessments are based on a cost per Assessable Unit of Frontage (AUF) of \$52.00. No owners of property within LID 8643 contested their proposed assessments either at the hearing or by written comment. The evidence presented demonstrates that the Final Assessment Roll conforms to applicable legal requirements, and the Examiner recommends approval of the Assessment Roll for LID 8643.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

All property owners within the boundary of the LID were notified of the public hearing, held on January 14, 2021, at which they could attend to express their concerns and voice support for, or opposition to the Final Assessment Roll of LID 8643. At and after the hearing, a few property owners did ask clarifying questions to the City's Department of Public Works LID Section representative. Property owners also had the opportunity to send written comments to the Hearing Examiner's Office post-hearing. Property owners within the LID boundary have benefitted from the improvements, the option of receiving long-term financing from the City, and from the City's contribution to the LID.
