SUBJECT:	Consideration of an Honorary Street Naming Request ("Bill Evans Place")
	for North 27th Street between Proctor and Madison Streets
DATE:	July 10, 2024

PRESENTATION TYPE:

Request for Resolution

SUMMARY:

In accordance with Resolution No. 41009, which is related to the City's Policy on Place Names and Name Changes, honorary street naming requests for roadways are to be reviewed as follows:

- an ad hoc work group consisting of representatives from designated City Departments determines if the City's naming criteria has been met and makes a recommendation in support of or against the naming application (Section 3, Subsection 4.b.ii);
- the work group's recommendation is shared with the City Attorney's Office for legal review (Section 3, Subsection 4.b.iii);
- the naming request is presented to the Infrastructure, Planning, and Sustainability (IPS) Committee and the Committee makes a recommendation and forwards the request to City Council for further consideration (Section 3, Subsection 4.c.i.-iii.).

The request for honorary street naming of North 27th Street (one block in length between Proctor and Madison Streets) as "Bill Evans Place" (and to be signed as "Bill Evans Pl.") has been reviewed by the entities designated in Resolution No. 41009. These Departments have confirmed the application meets the City's naming criteria, have given recommendations in support of the naming application, and therefore request the IPS Committee forward this honorary street naming request to full City Council. If adopted, two new additional street name signs (one at each end of the block)—with a brown background color as expected for street naming of this type—will be added atop the existing, and to remain, official North 27th street name signs with their customary green background.

BACKGROUND:

In April 2024, the Mayor's Office received a request from Deidre Evans to establish an honorary street name of "Bill Evans Place" in honor of her father. Mr. Evans called Tacoma his home for nearly 50 years (having passed away in 2023) and was a business owner/merchant (which he considered first and foremost despite being a Councilmember from 2000-2008) and supporter of the Proctor Business District by being the charter member of the Proctor Merchants Association. He helped in the creation of the Proctor Farmers Market, as well as Proctor Treats, and was the driving force behind the installation of the Doc Farrens street clock at the intersection of North 27th Street and Proctor Street. The application requests the City bestow honorary street name signing in association with the single block of North 27th Street between Proctor and Madison Streets.

Detailed information, including required naming application components, letters/signatures of support, and responses from the ad hoc work group, can be found in the Appendix to this memorandum.



ISSUE:

Mr. Evans' contributions to the City in the form of leadership, community building, and public service meet all the criteria set forth in the City's naming policy. City staff concur with requester's proposal, including the documented support from community members, and therefore recommend the IPS Committee vote in support of forwarding this request to full City Council.

ALTERNATIVES:

If the honorary name is not approved, there would be no changes to City infrastructure.

FISCAL IMPACT:

The fiscal impact of an honorary street naming request is described in Section 5, Subsection 2 of Resolution No. 41009 which states, "City costs involved in the name changes of a roadway, including honorary naming, shall generally be the responsibility of the applicant." The primary cost is associated with fabricating and installing the new signs; the expected cost for this proposal is approximately \$500. The applicant has been made aware of these estimated costs and will either bear the costs or will submit a statement of financial need as allowed by the resolution. If the latter, then the City could absorb the costs within the adopted operating budget.

RECOMMENDATION:

Honorary naming of this specific city block is fitting and appropriate due to Mr. Evan's presence within, and influence on, this particular business district and associated community.

In congruence with Resolution No. 41009, staff recommend the IPS Committee vote in support of forwarding this honorary street naming request to full City Council, which establishes the honorary naming of "Bill Evans Place" (to be signed as "Bill Evans Pl.") for the one-block segment of North 27th Street between Proctor and Madison Streets in honor of the late Bill Evans, if adopted by the City Council.

Application Content (as submitted by the applicant):

Bill Evans Place


Bill Evans 1940-2023 called Tacoma, WA home for nearly 50 years. In the early 70's Bill and his wife Ann moved to Tacoma. In the late 70s, after having two shops in Old City Hall, he moved the Pacific Northwest Shop to the north end's Proctor District. The shop which is still there today is located at 2702 North Proctor. Bill was an active member of the community for the past 50 years. He was a founding member of the Proctor Merchants Association (now Proctor District Association). He was involved in the creation of the Proctor Farmers Market in the 90s as well as Proctor Treats. Additionally, he helped bring the Junior Daffodil Parade to the Proctor District. He was responsible for seeking local investors to save the Blue Mouse Theater and he co-authored the Arcadia book on the History of the Proctor District. Bill owned and operated two local businesses in the Proctor District that are still present today: The Pacific Northwest Shop and The Proctor Mercantile (previously The Old House Mercantile). Over the years, he also opened a number of other stores in Proctor such as The Old House Cafe, the Proctor Antique Mall and the 'Christmas Store' dating back to the 80 and 90s. Bill advocated for public art on Proctor and commissioned a mural of Mt. Rainier which use to welcome those that drove into the neighborhood from 30th Street. He was also involved in the development of the mural currently on the Blue Mouse and the one on the side of the build which houses Teaching Toys. Bill was the driving force behind the installation of the Doc. Farren clock currently at the corner of 27th and Proctor which to this day is admired by visitors to the district. Bill dedicated nearly half his life to the growth and beautification of our local Proctor District. In recent years, he partnered with others to bring both Proctor Station as well as Madison 25 to the district. Bill was a very strong advocate of urban walkable communities. He supported countless small businesses within our community. Although Bill was a Tacoma City Council Member from 2000-2008, he always saw himself as a merchant first. In addition to the activities, he was involved in within the Proctor District he was also involved in projects city wide. He was on a number of Board locally, To name a few: Sister Cities International, Chinese Reconciliation, Citizens for the Healthy Bay, World Affairs Council. Through his church activities at St. Leo Catholic Church, he was heavily involved in the sanctuary movement.

In conclusion, this proposal meets the criteria in the policy for honorary names because it directly reflects the history of the location which Bill Evans was an integral part of shaping. In addition, the honorary name is associated with the life of a person of citywide significance in Tacoma's past. Bill Evans enhanced the quality of life for Tacoma residents through outstanding leadership and community building, including serving as a City Council Member.

Finally, the honorary name will not impair emergency response or the City's ability to provide services; it is not a duplicate name; it is not conferring preferential treatment to any service or business; it is not perceived to be discriminatory or derogatory; it will not result in

inappropriate abbreviations or acronyms; and there has been no honorary name or roadway renaming in this location within the previous 15 years.

We are honored that Mayor Victoria Woodards and Council Member John Hines initiated the discussion around honoring all that my father has done for our local community. He loved the Proctor District and I cannot think of a better way to recognize the love, dedication, and commitment he had for the City of Tacoma. Thank you!

Outreach Efforts & Support (as supplied by the applicant):

On 4/1/24 we meet with Mayor Victoria Woodards and Council Member John Hines. The city shared their idea to honor Bill Evans in Proctor with an honorary street name. The family was very excited and agreed with Mayor Woodards on her recommendation to name the location 'Bill Evans Place'. On 4/4/24 Anya Evans announced the plan at the Proctor Business District Association meeting to honorarily name the street in honor of Bill Evans. The group clapped and all present shared their approval.

Ad Hoc Working (Review) Group & Additional Agency Stakeholders:

Ad Hoc Group Review Comments:

Transportation: "Per the guidance/parameters checklist for this process, the overall request is approved from "Traffic" perspective, including lenience extended for desired use of "Place" as honorary street name "suffix" even though it doesn't exactly conform to guidance/Design Manual allowances, but is also not outright disallowed for this proposed location/situation. Additionally, and even though payment for the honorary signs is a requirement, there will be aspects of the total cost to implement that will be borne by the City since the addition of the honorary signs provides an impetus to update well-worn other signs and sign posts that will be physically supporting the official street name signs and the honorary name signs."

Office of Equity & Human Rights: "Applicant provided pertinent information and necessary details to indicate this request to promote equity, belonging, and advancing the community's and district's wellbeing. Bill's tenure aligns with all City of Tacoma values, guiding principles, and equity initiatives, resolutions, and efforts. The OEHR has no concerns of this request and foresees minimal unintended consequences or impacts however, should any arise – we'll address them at that time."

Government Relations: "It does not appear that this property is located on Puyallup Tribal land or that a name of tribal significance is involved in the renaming."

Real Property Services: "Not much for RPS to review on NAME24-0001 other than to confirm it is public ROW."

Agency Stakeholders Response/Comments:

South Sound 911: "Thank you for including South Sound 911 on this notification. We have no issue with this honorary street name for the 1-block segment of N 27th ST, with the official street name signs continuing to be used and no altering to existing addressing.

We highly appreciate you including us and please keep us posted as to the implementation of this, so we can implement a street name alias of BILL EVANS PL for N 27th ST."

Pierce Transit: "Thank you for including Pierce Transit in this review. We see no issue with this Street renaming on our end and will notify the appropriate Pierce Transit staff. Please continue to keep Pierce Transit updated on this and future street naming proposals."
