1. <u>24-0861</u> Transportation Commission Interviews

At approximately 4:33 p.m., Nicole Emery, City Clerk, informed the Committee they would be interviewing three applicants for the Transportation Commission and reviewing the applications of two Commissioners seeking reappointment.

Council Member Bushnell arrived here, at 4:35 p.m.

The Committee interviewed Augustus Curnow, Christiano Martínez, and Quanah Spencer.

The Infrastructure, Planning, and Sustainability Committee reviewed applications for those seeking reappointment.

Discussion ensued regarding the qualifications of the applicants.

2. 24-0862 Streets Initiative 2 Timeline and Feedback
 [Ramiro Chavez, City Engineer and Director;
 Joseph Franco, Special Assistant to the Director, Public Works]

At approximately 5:14 p.m., Ramiro Chavez, City Engineer and Director, and Joseph Franco, Special Assistant to the Director, Public Works, presented the Streets Initiative (SI) 2 timeline and feedback, including an overview,

noting the 2015 voter approved Proposition Nos. 3 and A; background, noting both measures will expire in December 2025; SI successes; 2024 quarter two updates, noting meetings with Council Members to discuss goals for a potential ballot measure, Fehr and Peers selected to finalize the Transportation Impact Fee framework, Ordinance No. 28965, the first Public Works Summit, Pothole Palooza, and survey results released through the City Manager's report; 2024 quarter three updates, noting scheduling external and internal outreach, and ongoing briefings with the full Council; and proposed next steps, noting upcoming presentations, proposed extension, and expiration date.

Discussion ensued regarding property tax increases, road conditions, sidewalks, communication timeline, April 2025 ballot measure, SI website and map, funding for transit, Supreme Court decision regarding transportation impact fees, and Transportation Master Plan working with SI 2.
