TCAB member Ava Sims asked if any Youth member in the past has filled a Vice Chair position. He also shared some quick updates regarding the Division Manager recruitment process, and upcoming funding application review. Lisa Jaret shared more details around the opportunity for TCAB members to test the current application form. Lastly, updates were shared around the January meeting being scheduled, and upcoming committee opportunities for TCAB to engagement in 2024.
