At approximately at 4:34 p.m., Vicky McLaurin, Systems and Strategy Division Manager, Neighborhood and Community Services, and Dawn Couch, Senior Project Manager, BERK Consulting, together presented on the Tacoma Mental Health and Substance Use Disorder (MHSUD) funding assessment, including an introduction and overview, mental health and chemical dependency sales tax, Tacoma's MHSUD funding timeline, and the funding assessment purpose and components. They then reviewed the quantitative assessment findings, including a high-level overview, MHSUD funding levels remained stable while the number of agencies funded increased, funding prioritized homeless and housing stability, staff positions supported by the funding. They further outlined the qualitative assessment, including the purpose, provider questions, and direct beneficiary questions,

gaps in Tacoma's system of MHSUD services, system challenges facing MHSUD providers and those in need of MHSUD services, Tacoma's MHSUD funding priorities and process, and what's next.

Discussion ensued regarding funding; barriers, noting undocumented individuals, and youth; tracking; provider requirements; and grant writing.
