Government Performance and Finance Committee

He concluded by stating at the February 17, 2016 meeting, the Committee heard presentations relative to the implementation of building inspection fees, and for-hire regulations.

Mayor Strickland provided additional questions that have been raised regarding the proposed methanol plant, provided comments on maintaining the integrity of the review process, and why other jurisdictions have the ability to provide comments for or against the proposed plant.
