#### FINAL READING OF ORDINANCES

## 2. ORD28508

(First and Final Reading) An ordinance amending Title 1 of the Municipal Code, entitled "Administration and Personnel", by adding a new chapter, to be known and designated as Chapter 1.95, entitled "Tenant Rights Code", requiring residential landlords to provide 90 days' written notice prior to terminating a month-to-month tenancy under certain circumstances; adding a new Subsection 1.23.050.B.40, placing appeals related to violations of Chapter 1.95 in the jurisdiction of the Hearing Examiner; providing a sunsetting date of September 30, 2018; and declaring an emergency, making necessary the passage of this ordinance and it becoming effective immediately.

MOTION: Council Member McCarthy moved to amend Exhibit "A" of Ordinance No. 28508, at page 6, line 5, to add a new Subsection C to Municipal Code Section 1.95.020, entitled "Ninety-day tenant notice," to read as follows: C. The notice required herein does not apply when:

1. An owner terminates for nonpayment of rent or for other cause allowed by the State Residential Landlord-Tenant Act, chapter 59.18 RCW; or 2. An owner is required to repair the dwelling unit due to a violation of the Minimum Building and Structures Code, Tacoma Municipal Code 2.01.050, and is either derelict or unfit.

Assistant City Manager Tadd Wille stated the City is in connection with United Way in efforts to provide enhanced services through June 30, 2018, including the dedicated 211 resource phone line, case management, referrals to resources, and to provide regular updates to the City Council and City staff on Tiki Apartments residents' progress in finding housing. He further stated the Office of Equity and Human Rights staff are investigating on potential violations of the Landlord Tenant Act at Tiki Apartments by working on-site twice per week at times that are most convenient for tenants to interview tenants and assist with their needs or ask the landlord for reasonable accommodations. He concluded by stating the City is working in partnership with Tacoma-Pierce County Housing Justice Project to provide legal services to Tiki tenants.
