At approximately 10:05 a.m., Doris Sorum, City Clerk, informed the Committee that they would be interviewing five applicants for the Tacoma Creates Advisory Board, two of which are seeking reappointment; and that there are currently three positions available, including the Arts, Heritage, and Council District No. 3 positions. Ms. Sorum further stated a prior discussion was held regarding the reappointment of Putter Bert and Roxane Hreha, and that Maeve Glackin-Coley was selected for the Youth position by the leadership team of the Mayor's Youth Commission.

The Committee interviewed Allison Campbell, Naomi O'Connor, Brian Robinson, and Jacob Tice. Rosie Delcid Castillo did not attend.

Discussion ensued throughout regarding the number of available positions, which applicants could fill which positions, and applicant qualifications.
