1. Call to Order; Roll Call

Chair Cooks provided space for attendees to share public comment. There were no public comments made at this time.

Clarissa Gines shared updates on the new Tacoma Creates position, and announced that the 2022-23 Funding Application and Guidelines were released on January 25th. She also shared information on upcoming application workshops.

Lisa Jaret then updated TCAB on the currently funded organizations, and presented some quotes from funded organizations about the impact of funding, which were read by TCAB Members Allison Campbell, Naomi O'Connor, Roxane Hreha, and Maeve Glackin-Coley.

6. TCAB Engagement/Operations

Chair Cooks briefly shared some committee and panel updates, and thanked TCAB members for being willing to participate.

Changes to three meeting dates were discussed. A special meeting will be scheduled for Monday, May 23rd to approve Impact Funding recommendations, the September meeting will be moved to Monday, August 29th due to Labor Day; and the July meeting will be canceled.

Lisa Jaret introduced Bucoda Warren, the City's Strategic Initiatives Coordinator, who presented information on the City's Equity Index.

Chair Cooks facilitated questions after the presentation.

8. OACV Staff Reports

Amy McBride shared some brief information on the Black Lives Matter mural, led by artist Dionne Bonner. This project is a collaboration between the City of Tacoma's Human Rights Commission and the Tacoma Art Museum with funding support from the City of Tacoma, the Tacoma Arts Commission and Tacoma Creates.

9. Closing Comments

Vice Chair Bert, TCAB Members

Lisa Jaret shared a re-framing on how TCAB members will be reporting on their engagement with Tacoma Creates-funded programs. Brian Robinson presented a short video of the WAR concert that he attended at the Pantages (presented by Tacoma Arts Live). Lies Santkuyl and Amanda Figueroa also engaged in Tacoma Creates-supported events from Tacoma Arts Live and Tacoma Tree Foundation.

A preview was also shared on upcoming speakers for the next two TCAB meetings.
