

1. Call to Order 5:03 pm (00:05)

4. Public Comment on Agenda Items

(02:55)

There were no public comments on agenda items.

5. Action Items

a. E. 64th Street, Phase II Proposal Updates

(04:22)

Staff introduced Elisheba Johnson, providing a brief overview of the E. 64th Street, Phase II public art project.

Elisheba spoke about the design of her medallion projects, drawing on community engagement culture maps to inform the look and design. She provided examples of the various mosaic medallion designs, which were composed of Mexican and Japanese tiles, wax prints, and other mixed materials. The Puyallup Tribe has translated the poetry text from the first stage. There will be five poetry markers in Lushootseed. Bose Elementary students provided words to inspire a poem created by the artist. Commissioners asked questions and provided comments.

Staff asked for a motion to approve the updated artwork proposal for E. 64th Street, Phase II.

b. Tacoma Artists Initiative Program Funding Recommendations

(22:40)

Staff shared an overview of the 2025-2026 Tacoma Artists Initiative Program review process. Seventy-two eligible applications were received, and the panel recommended funding for 25 applicants at \$4,000 each, totaling \$100,000. The artists recommended for funding are: Brendan Allen, Curtis Ashby, Vaquero Azul, Tor Caspersen, Saign Charlestein, Sarah A. Chavez, Cennady Coleman, Alex Fazekas-Boone, Aaron Green, Mari Griffin, Erin Guinup, Jenny Liou, Jason Loan, Mel McCarthy, Stephanie Meredith, Julia Micke, Yaya Mulvey Moir, Teresa Owens, Allison Preisinger, Adela Ramos Marché, Saiyare Refaei, TQ Spellman, Jessica Spring, Helen Thorsen, and Kristin Tollefson.

Commissioners Dean and Ng spoke about the panelists' perspectives, evaluation criteria, and key discussion areas and noted that the selected artists represented a balanced mix of districts, artistic styles, and project types.

Staff noted that, since the City is still in a budget freeze, the Commission can move forward with approving the funding recommendations, but that funding is subject to availability. Commissioner Ng emphasized the importance of TAIP artists' work and encouraged greater recognition of their contributions. Commissioners discussed ways to connect all applicants, selected or not, through workshops, social meetups, opt-in contact lists, the Tacoma arts listserv, and other engagement opportunities.

a. Staff Projects Overview and Updates – Funding, Community Programming, Public Art, Tacoma Creates Staff gave updates about the following items:

- City of Tacoma's budget freeze is still in place.
- Tanja Carter, the new Community & Economic Development Department Director, starts on March 24.
- Arts & Cultural Vitality Division's 2024 Annual Report is currently in design, with a goal to complete it by the end of March.
- ArtTown show with TV Tacoma is being integrated into a new program called The 253, which
 will cover arts, culture, environment, civic engagement, local businesses, and other topics, airing
 roughly quarterly.
- Public Works Artist in Residence is working on the Pride Crosswalk, storm drain murals, and a potential artistic crosswalk at Lincoln Heights Park.
- Environmental Services Artist in Residence programming including collaborations with Ground to Sound Film Festival, South Sound Sustainability Expo, and workshops at Tacoma Public Library.
- An upcoming mural for Oakland High School, in collaboration with Tacoma Public Schools.
- An open call to create designs related to the salmon life cycle.
- An assessment of some pieces in the Municipal Art Collection that are being considered for deaccession.
- Granite pavers for the Hilltop Plaque project have been delivered to Tacoma and should be installed soon.
- Tacoma Creates' Comprehensive Organizational Support applications are due March 10 and Impact Funding applications are due March 24.
- The Tacoma Creates reauthorization timeline has shifted to May-July. Council is exploring potential updates to Tacoma Creates related to capital funding, support for rental facilities, and capacity support for outdoor fairs and festivals.
